Subject: Reiteration of instructions to empanelled Health Care Organizations to provide consultation/ treatment / investigations to Hon'ble Members of parliament on Cashless basis

With reference to the above subject, the undersigned is directed to convey the approval of Competent Authority to reiterate instructions to CGHS empanelled Health Care Organizations(HCOs) regarding consultation/ treatment / investigations to Hon'ble Members of Parliament as under:

- i) The CGHS empanelled HCOs shall provide consultation/treatment / investigations to Hon'ble Members of Parliament and their dependant family members on cashless basis on the basis of referral letter and submit the hospital credit bills to Lok Sabha Secretariat/Rajya Sabha Secretariat as the case may be.
- ii) The CGHS empanelled HCOs shall not ask Hon'ble Members of Parliament and their dependant family members to obtain permission letter from Rajya Sabha Secretariat/Lok Sabha Secretariat as the case may be, where a specific listed treatment procedure / investigation has been advised by Govt. Specialist/CGHS Medical Officer. Such treatment/investigations shall be provided on cashless basis.
- iii) The empanelled HCOs shall not refuse admission to Hon'ble Members of Parliament and their dependant family members.
- iv) The empanelled HCOs shall extend due courtesy and care to the Hon'ble Members of Parliament and their dependant family members and sensitize their staff to ensure that Hon'ble members of Parliament and their dependant family members are not subjected to any inconvenience.
- v) The empanelled hospitals shall provide treatment/ Consultation in all Specialties available in the hospital.

2. The CGHS empanelled Health Care Organizations(HCOs) shall strictly comply with the above guidelines.
